# WHAT A DOLLAR BUYS

In Miami County, 34% of households cannot afford the basics of housing, food, health care, and transportation. Within the 34% of households, 15% are living below the federal poverty level and another 19% are living above the poverty level but below the cost of living. We call this population ALICE, which stands for Asset Limited, Income Constrained Employed.

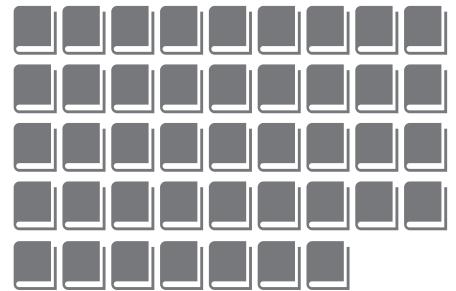

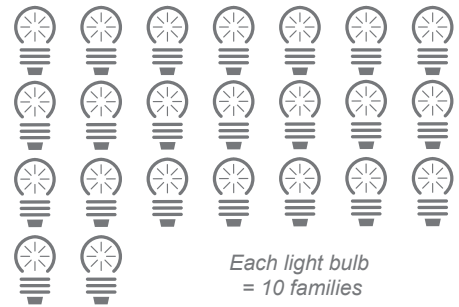
